**Please Read and Follow Instructions****1. How to mark your Ballot When Voting:**

Mark an "X" on the line next to your candidate(s) choice for whom you are voting . (Example:  Joe Blow). A vote for yourself is considered a valid vote. ----OR---- Write in your own name or a candidate's name of your choice in the Write-In Section.

**2. Write-in Candidates:**

Write in the name of a candidate of your choice below the "Write-In Candidate" area. You may write in your own name, if you wish, for any position on the Ballot.

Download, fill out and attach the Write-In Candidate Information form and attach it to your Ballot. **You must write your Ballot number on the Write-In Candidate Information form.**

Please read the "Candidate Eligibility" document in the Election section of the above website address.

**The deadline date for transmitting the Write-In Candidate's required documents to the National Election Judge is September 09, 2017.**

**3. National Offices: (not applicable this election)**

All eligible voters may vote for only ONE president and ONE vice president or write-in a candidate for each office.

**4. District Offices:**

All eligible voters who are domiciled in the jurisdictional republic of Texas counties for the district where they are domiciled may vote for the Senate Seat candidate and Judicial District Office Seat candidate or you may write-in a candidate. Read above instructions for write-in candidates.

**5. County Offices:**

All eligible voters who are domiciled in that named county may vote for House Representative(s), or county positions as listed or may write-in a candidate's name or if more than one position is required you may write in one candidate's name for each position.

**6. CASTING YOUR BALLOT:**

When you have completed your Ballot and Write-In Candidate form(s), if applicable, send your Ballot plus your Write-In Candidate Information form(s) via United States Postal Service to Secretary of State, Republic of Texas, US Post Office Box 280, lola, Texas [77861]

**WARNING !!! Failure to follow instructions will disqualify your vote. Ballot must be post marked no later than September 05, 2017.**
